

# Rex Kenyon Memorial Fort Hood Campership Fund Request For Scouts from US Army stationed at Fort Hood, as well as Gold Star families and Retired Army families living in the Fort Hood area.

Chief Warrant Officer 3 Rex Kenyon is an Eagle Scout who served his country in the US Army as an Apache Helicopter gunship pilot. He was stationed at Fort Hood, Texas. Rex was shot down during a combat mission while serving in Operation Iraqi Freedom on January 16, 2006.

NOTE: US Army Warrant officers hold warrants from the Secretary of the Army and are specialists and experts in specific military technologies or capabilities. When a Warrant officer is promoted to Chief Warrant Officer 3, they receive a Commission from the President of the United States. Commissioned warrant officers are direct representatives of the President of the United States. They derive their authority from the same source as commissioned officers but remain specialists - like helicopter pilots - in a specific area of military service throughout their career, in contrast to commissioned officers, who are generalists.
